## Aurora Labs expands its distribution network to Africa

Aurora Labs Limited ("Aurora" or "the Company") (ASX:A3D), is pleased to announce that it has signed a distribution agreement with Weartech Pty Ltd ("the Distributor" or "Weartech") based in South Africa. Weartech has exclusive distribution rights to Aurora's Small Format Printers (SFP) in South Africa. In addition, Weartech has been granted a non-exclusive distribution license in the 14-member countries of the Southern African Development Community. As part of the agreement, Weartech will have responsibility for all of these countries for sales, warranty repairs, servicing, training, of the SFP as per Aurora's other major distributors. The financial terms of the agreement are commercial in confidence.

The agreement with Weartech includes the supply of a demonstration printer and opens up a number of potential opportunities for Aurora in new markets while strengthening the Company's geographical reach.

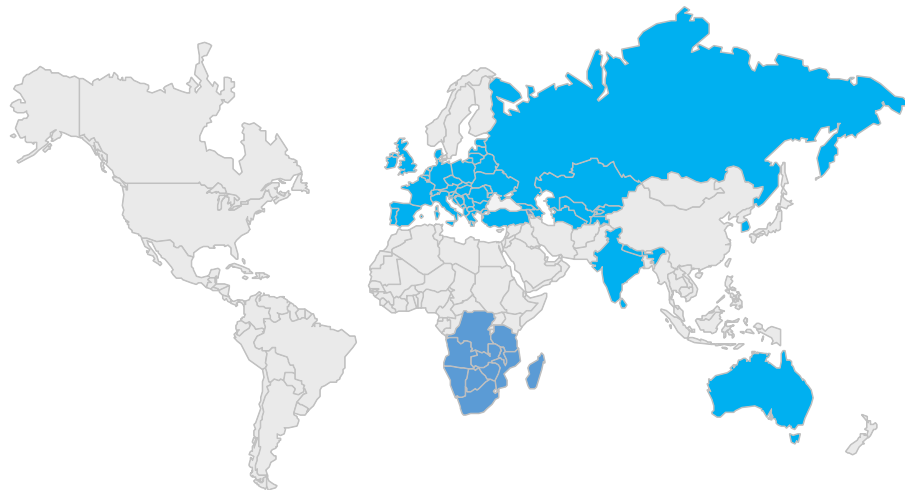
