A3D Resumes Customer and Technology Development Printing

Aurora Labs Limited (“A3D” or “the Company”) (ASX:A3D), is pleased to announce the successful recommissioning of its printers following a recent relocation to the Company’s new Canning Vale facility.

A3D’s Beta prototype has printed its first test coupons since the move, relaunching the Company’s Technology Development Pathway campaign, with the focus on achieving the Phase Two Parameter Development Milestone. The goal of the milestone is to advance the printing of quality parts at high power with the prototype’s improved extraction system in place and A3D will report on this milestone in July 2021. Completion of the Technology Development Pathway is expected within the September 2021 quarter due to the short-term productivity impact associated with the business relocation.¹
